

# The National Health Service Superannuation and Pension Schemes (Miscellaneous Amendments) (Scotland) Regulations 2019

#### **Consultation Report**

1.1 The Scottish Public Pensions Agency (SPPA) is grateful for the number of responses made to the consultation on The NHS Superannuation and Pension Schemes (Miscellaneous Amendments) (Scotland) Regulations 2019. The purpose of this report is to provide stakeholders with a summary of feedback received to SPPA's consultation which ran from 20 December 2018 to 18 January 2019 on the above draft regulations. This document also sets out SPPA's reply to stakeholder comments and proposed next steps.

#### 2 Executive Summary

- 2.1 The NHS Superannuation and Pension Schemes (Miscellaneous Amendments) (Scotland) Regulations 2019 will make amendments to The NHS Superannuation Scheme (Scotland) Regulations 2011, The NHS Superannuation Scheme (2008 Section) (Scotland) Regulations 2013 and The NHS Pension Scheme (Scotland) Regulations 2015. The primary aims of these Regulations are to introduce an increased employer contribution rate from 1 April 2019 and to make changes to the salary/earnings bands of the employee contribution tables in respect of the scheme year 2019/20.
- 2.2 All unfunded public service schemes are required to undertake quadrennial scheme valuations. The process and financial assumptions used to undertake a scheme valuation are set out in the Public Service Pensions Act 2013 and HM Treasury Directions. The latest valuation, based on scheme data as at March 2016, has confirmed an increase in the employer contribution rate from 14.9% to 20.9% and that rate, as required by the Directions, has to be applied for the period 1 April 2019 to 31 March 2023. The Directions were recently amended to reflect both the change in the discount rate used in the scheme valuation and the Chief Secretary to the Treasury's written statement on 30 January to the Westminster Parliament. <a href="https://www.parliament.uk/business/publications/written-questions-answers-statements/written-statements/">https://www.parliament.uk/business/publications/written-questions-answers-statements/</a>
- 2.3 The discount rate is the notional investment return on contribution income and a change in the rate from CPI+2.8% to CPI+2.4% was announced in the UK Government's October 2018 Budget statement. The valuation assesses what each scheme needs now in order to meet future liabilities. The lower the discount rate, the higher the level of funding needed now to meet those future liabilities and that feeds through to employer costs. Hence, a reduction in the discount rate feeds through to higher employer contributions.



- 2.4 Following the closure of this consultation the Chief Secretary to the Treasury's written statement of 30 January 2019 confirmed that the employer cost cap rectification of the unfunded public service schemes should pause. The written statement also confirmed that the proposed increase in the scheme employer contribution rate to 20.9% should continue given the potential costs that would be faced by schemes resulting from the McCloud/Sargeant Court of Appeal decision on 20 December 2018 (Case number A2/2018/0635). The Court of Appeal found that the transitional protections applied as part of the 2015 reforms discriminated on the grounds of age although the UK Government has sought leave to appeal that decision.
- 2.5 The changes to salary/earnings bands of the employee contribution tables in respect of the scheme year 2019/20 will ensure that the tiering of pay bands remains in line with annual increases in members' pay. It was agreed during scheme reform discussions with both scheme employer and scheme member representatives that, although member contribution rates would not change, the pay/earnings bands in each tier would increase each year in line with national NHS pay awards in Scotland.
- 2.6 Prior to the issue of the consultation the impact of the scheme valuation both on the employer contribution rate and the employer cost cap was discussed by the Scheme Advisory Board (SAB). The SAB provides advice to the Scottish Ministers on the desirability of changes to the design of the scheme, the implication of other policy issues and is made up of employer and member representatives from across the service. Its advice includes providing remedies to rectify a provisional breach of the employer cost cap and in doing so had reached agreement on a number of proposals which were due to be formally considered by the Scottish Ministers. However following the Chief Secretary to the Treasury's written statement of 30 January 2019 employer cost cap rectification work in all unfunded public service schemes has paused until the outcome of the McCloud/Sargeant case is known.

#### 3 Analysis and Reporting

- 3.1 The consultation received 1,768 responses. The vast majority of replies were received from GPs, on behalf of GP practices or from GP member organisations. Third sector employers were also represented amongst the responses.
- 3.2 While there were a large number of responses to the consultation, almost all of the comments centred around common themes which are summarised below:
  - The negative impact of employer contribution increase on the stability of General Practice in Scotland and its ability to deliver services
  - The negative impact of employer contribution increase on charity organisations who employ NHS Scotland staff and their ability to deliver services
  - The negative impact of employer contribution increase on the ongoing viability of GP practices



- The negative impact of employer contribution increase on GP income
- The negative impact of employer contribution increase on the recruitment and retention of GPs
- The negative impact of employer contribution increase on the number of GPs leaving the pension scheme or retiring early
- The negative impact of employer contribution increase on continued employment of GP practice staff
- The timing and length of the consultation and its suitability in order to allow all interested stakeholders to submit a response
- The perceived impact on the value of the pension scheme and the increased number of GPs leaving the pension scheme as a result of Lifetime and Annual pension tax allowances
- 3.3 In addition to these common themes detailed above, the BMA Scotland also raised the specific issue of moving to a flatter employee contribution structure and questioned the fiscal justification for the current tiered contribution structure in the CARE scheme. This issue is out of scope of the consultation but is one that is currently being considered by the NHS Scheme Advisory Board (SAB).

#### 4 SPPA's Response

- 4.1 Unfortunately, the timeframe for the consultation on the regulations introducing this change was limited, principally due to the UK Government's late change to the discount rate which impacted on the valuation timetable. Discussions within the NHS SAB continued to seek agreement on how the cost cap breach would be rectified, with the aim that any agreed changes would be implemented from 1 April 2019. These discussions have now been paused in line with the UK Government's decision to suspend the cost cap process. However, in December, the discussions were detailed and there was a risk that agreement would not be reached in time to allow the necessary legislation to be put in place. SPPA therefore issued a short consultation on the increase in employer contributions, which was known, to ensure it would be implemented for 1 April 2019.
- 4.2 SPPA recognise that the proposed increase could have a significant effect on NHS employers and in particular GP contractors who are both members and employers under the schemes. Scottish Government officials are engaged in discussions with HM Treasury regarding the level of funding it will provide to schemes to cover this increase and Scottish Ministers have insisted that those costs should be met in full.
- 4.3 It is important that the cost of pension rights is met in full by staff and their employers at the point those liabilities are incurred, and avoid leaving deficits for the future. The new rate reflects the SCAPE discount rate changes and makes provision for the increased cost of NHS pension benefits going forward.
- 4.4 There is no impact on Lifetime and Annual pension tax allowances from the increase in the employer contribution rate. For Defined Benefit schemes like the NHS scheme, although employer contributions are taken into account when assessing a member's adjusted income for the purposes of the tapered Annual Allowance limit, it is the value of those contributions, rather than the actual amount paid, that is taken into account. Therefore the actual rate of employer contributions is not relevant in AA calculations and is not affected by the increases in employer contributions being introduced from 1 April 2019. The Lifetime Allowance is based on the value of the member's pension benefits, which is not affected by the employer contribution rate.

#### 5. Next Steps

5.1 SPPA brought forward regulations to the Scottish Parliament to reflect the changes to the scheme regulations as set out above.
