# DRAFT REGULATIONS - THE LOCAL GOVERNMENT PENSION SCHEME (MANAGEMENT AND INVESTMENT OF FUNDS) (CONSOLIDATION AND AMENDMENT) (SCOTLAND) REGULATIONS 2010

- 1. As you know, on 16 July 2009 SPPA began a consultation exercise (which ended on 9 October) on possible changes to the Local Government Pension Scheme (Management and Investment of Funds) (Scotland) Regulations 1998 ("the 1998 Regulations"). Of the responses received (copies of which can be viewed on request) the majority were content with the proposals.
- 2. I now attach draft regulations relating to those proposed changes. You will note that the opportunity has also been taken to consolidate the 1998 Regulations.
- 3. Your technical comments on the draft regulations are now invited and they should be returned to SPPA **NO LATER THAN FRIDAY 18 DECEMBER 2009**.
- 4. The consultation exercise in July also proposed an amendment to the Local Government Pension Scheme (Administration) (Scotland) Regulations 2008, requiring administering authorities to publish a pension fund annual report. Since then, stakeholders have suggested, and SPPA has agreed, that a number of other, minor, changes should be made to those Regulations and also to the Local Government Pension Scheme (Benefits, Membership and Contributions)(Scotland) Regulations 2008. Draft regulations introducing these changes will be the subject of a separate consultation exercise.
- 5. The proposed changes mentioned at paragraph 1 were set out in Annex A to the consultation letter of 16 July, and these are summarised in the attached Annex A in the regulation order that they appear in the draft regulations.
- 6. Please note also that regulations 2 and 4 have been amended to make references to the new Regulations which comprise the 2008 LGPS Scheme and which are consequential on the coming into force of the new scheme on 1 April 2009. Other drafting amendments have been



made so as to make the Regulations easier to understand and gender neutral. More generally, I would urge consultees to read through the draft Regulations carefully as the numbering is now slightly different to that of the 1998 Regulations.

### Separate audit of LG pension funds

7. In response to the 16 July consultation exercise some stakeholders have asked that the Regulations be amended to provide for a separate audit of the Local Government pension funds. This issue is under consideration.

#### Handling your response

- 8. All respondents should be aware that the Scottish Government is subject to the provisions of the Freedom of Information (Scotland) Act 2002 and would therefore have to consider any request made to it under the Act for information relating to responses made to this consultation exercise.
- 9. A Respondent Information Form is also provided at Annex B for completion and return to SPPA. Using this form will simplify our task of collating responses and will make the process more efficient.

#### **Next steps in the process**

- 10. Where respondents have given permission for their response to be made public these will be made available to the public in the Scottish Government Library after the consultation period. We will check all responses where agreement to publish has been given for any potentially defamatory material before logging them in the library. You can make arrangements to view responses by contacting the SG Library on 0131 244 4556. Responses can be copied and sent to you, but a charge may be made for this service.
- 11. Once the consultation has closed we will consider all responses when preparing the final Regulations.
